

# Potential versus actual infinity: insights from reverse mathematics

During April 1–4, 2015 I will serve as an invited Scholar of Consequence with the [University of Connecticut Group in Philosophical and Mathematical Logic](#). As part of that visit I will deliver their [Annual Logic Lecture](#). This document consists of an abstract and references for that lecture.

## Abstract

In the philosophy of mathematics, there is a crucial distinction between potential infinity and actual infinity. This distinction gives rise to four contrasting viewpoints: ultrafinitism, finitism, predicativism, and infinitism. I am convinced that of these four, finitism is the most objective. This conviction heightens the importance of Hilbert’s program of finitistic reductionism. Some relevant formal systems are PRA,  $WKL_0$ , IR,  $ATR_0$ , and ZFC. Foundational research over several decades has revealed that large parts of contemporary mathematics, including the applicable parts, can be formalized in systems such as  $WKL_0$  which are finitistically reducible. This seems to provide a possible outline for an objective justification of much of contemporary mathematics.
